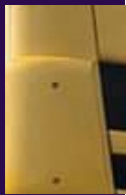

## CILT MEMBERSHIP

### Background

The Institute of Transport was founded on 3rd November 1919 at Savoy Hotel in London by a group of senior transport professionals. The Institute of Transport (CILT) was granted a Royal Charter by King George V in November 1926 “to promote, encourage and coordinate the study and advancement of the science and art of transport in all its branches”.

- The Institute was granted the name Chartered Institute of Transport (CIT) by Queen Elizabeth II in 1971.
- The Chartered Institute of Transport became Chartered Institute of Logistics and Transport in July 2001 as the two leading professional bodies joined together.

The CILT’s role has ever been education in the broadest sense: to spread transport knowledge and to be a source of authoritative views for communication to governments, industry and community. The Institute supports the professionals who plan the roads, drive the trucks, bring in the raw materials, and store the goods safely. We are the leading international voice for supply chain, logistics and transport.

### Vision

To be recognized globally as the first-choice professional body for the supply chain, logistics and transport industries.

### Objectives

- Offer education and training, and providing excellent opportunities for learning and development for members both at individual and corporate level.
- Give members the tools they need to realize their ambitions and to progress throughout their career for life.
- Spread logistics, transport knowledge, and be a source of authoritative views for communication to government, industry and community.

### CILT Membership

The Institute encourage individuals and corporates to apply for membership that will assist them in professional development in the field of Logistics, Transport and Supply Chain. There are two categories of membership namely **assessed** and **non-assessed** and there are a number of grades in each of the category.

The assessed category is the only one that enable a member the privilege of carrying out the post nominal, (MILT, CMILT or FCILT) Individuals are required to meet specific criteria on the qualification and experience required for different membership grades. Applicants are elected or upgraded to a certain membership grade in accordance to such criteria. Applicants need to demonstrate different levels of knowledge of the Key Knowledge Areas (KKA) – (a) Awareness (b) Understanding (c) Competence (d) Expertise.

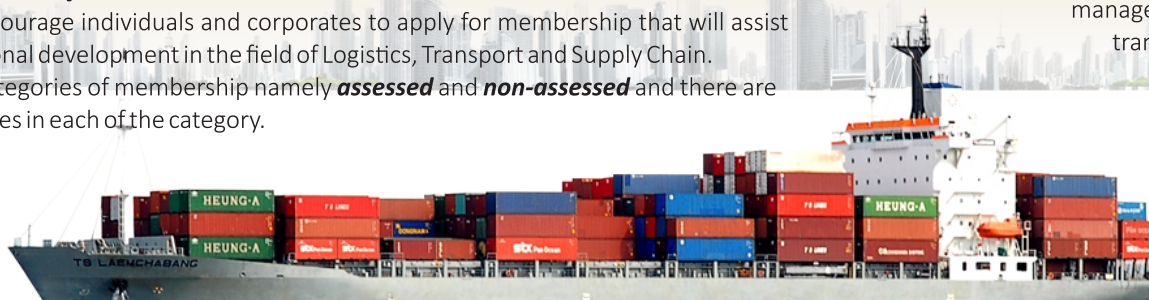
- Raise awareness of your organisation within the market place.

### Non-Assessed Category

1. **Associate** – The first membership step with no qualifying criteria.
2. **Student Member** - a student may join as an affiliate with the intention of taking CILT qualifications or aspiring to upgrade into the higher grade of membership in future. Admission is by direct entry.

### Assessed Category

1. **Member (MILT)**- applicant should ideally have completed the CILT Certificate or the CILT Diploma or another relevant exempting qualification, and have at least 3 years junior management experience in the logistics and transport sector. Members are entitled to use the post-nominal MILT.



2. **Chartered Member (CMILT)**- applicant should have completed the CILT Advanced Diploma, or another relevant exempting qualification, and have at least 5 years' experience in the logistics and transport sector, of which at least 2 years must be at a managerial level. Chartered Members are entitled to use the post-nominal CMILT and are allowed to vote at the AGM. In addition, there are specific routes to Chartered Membership for those people who have significant relevant experience but lack of formal educational qualifications.
3. **Chartered Fellow (FCILT)** - applicant should ordinarily already be a Chartered Member, and has at least 7 years high-level management experience in the logistics and/or transport sector. Chartered Fellowship may also be awarded, in exceptional circumstances, to individuals who have made an outstanding contribution to the logistics and transport sector, or those who have attained a position of eminence in their field, or who has special knowledge of the theory or practice of logistics and transport. Chartered Fellows are entitled to use the post-nominal FCILT and are allowed to vote at the AGM.

## CILT Membership Application Processes

The following listed are processes to be undertaken in order to upgrade or gain membership status:

- Complete a two page Membership Application Form.
- Attach all relevant documents mentioned in the application form; these includes Copies of Educational Qualifications / Certificates, Continuing Professional Development (CPD) Record and Plan, Detailed Curriculum Vitae (both hard & soft copies), Employers' Reference Letter and Organizational Chart.
- Those who are currently occupying senior management position must furnish their current company's background information including job nature, company size, number of employees, website address etc.
- Seek for two Institute Chartered Members in good standing to endorse your application forms and submit them to the CILT Zimbabwe at
